PART II. DESCRIPTION OF ACTIONS

Alexis Foundation has undertaken wide range of activities which promote the Ten Principles of United Nations Global Compact. Few of them are as follows:

1. Organized the **World Law Conclave (WLC)**, a leading platform for legal academia, professionals and students to come together and discuss the issues of contemporary relevance. The conclave had delegates from all over the world who engaged in two days of rigorous learning, reflection and sharing of knowledge, skills, experiences and perspectives. It will also provide attractive awards, prizes and networking opportunities to the delegates.

The second edition of the conclave was organized on 30th and 31st January, 2021 via Online Mode.

2. Organized the **Climate Change Conclave (CCC)** to take a step further in securing the future of the planet against the impending Climate Change crisis.

The CCC aims to bring together students, young professionals, social workers, activists, scholars, researchers, academia and the corporate sector to introspect on the activities that challenge the Earth's ecology and human safety, and ideate on possible solutions to face these challenges. We aim to utilize the CCC as a platform to enhance inter-organizational co-operation, sustainable thinking, and climate resilience and management.

The first edition of the conclave was organized on 27th February, 2020 at the Indian School of Development Management, Noida.

PART II. DESCRIPTION OF ACTIONS

3. Co-organized the **Indian Law Conclave (ILC)**, a two day National Legal Conclave. The conclave brought together academicians, lawyers, legislators, bureaucrats and students in order to encourage discussion over legal issues and promote multidisciplinary approach to the policy making process. It had delegates from all over India who will engage in two days of rigorous learning, reflection and sharing of knowledge, skills, experiences and perspectives. The conclave provided attractive awards, prizes and networking opportunities to the delegates.

The second edition of conclave was held on 10th and 11th August, 2019 at the International Youth Hostel, New Delhi and the third edition of the conclave was held on 31st October and 1st November, 2020 via Online Mode.

4. Supported various initiatives of the Alexis Group - **Samvaad 2020, Indian Economy Symposium 2019 and Indian Leadership Conclave 2019.**

5. Published a book - **Strategic Management and Entrepreneurship: A Reflection on the Last Three Decades and the Way Forward** in collaboration with IIM Ranchi, EDII Ahmedabad, and Strategic Management Forum.

PART II. DESCRIPTION OF ACTIONS

4. Implemented the **Action Plan 2020** to align our new initiatives and activities towards general principles of sustainability and transparency along with Ten Principles of UN Global Compact.

5. Organised the **Social Impact Conclave** on February 29, 2020 at the GLA University, Mathura. Themes of Discussion included Clean Water and Sanitation, and Climate Change. Collaborated with the Social Impact Alliance, and Advik Foundation.

6. Organised the **SDG Action Conclave** from September 18 – 26, 2020, a digital convening with changemakers and young leaders from around the world. Collaborated with the NOVUS, Youth Forum and Gyaanspace.

The recordings of the interviews were later uploaded to YouTube on August 15, 2021.

7. Our Founder, Aditya Singh was selected as an Inaugural Cohort Member of the **Climate Action Champions Network**, supported by the Department of State, USA and implemented by the Observer Research Foundation, India.

8. Our Founder, Aditya Singh was selected a Member of **Indo-Pacific Circle** - a network of thought leaders, supported by the US Mission in India and co-hosted by the Council for Strategic and Defense Research (CSDR), and the Centre for Policy Research (CPR).

PART III. MEASUREMENT OF OUTCOMES

Our initiatives and activities have yielded both quantitative and qualitative outcomes.

1. We have engaged 3,000+ delegates in various conclaves/events mentioned above. The delegates become our alumni/ambassadors/community members after the event and actively promote our commitment towards Ten Principles of UN Global Compact in their workplaces, universities, and cities.

2. We have trained 10,000+ students through our Webinars. These students research, create online and offline campaigns, and write blogs on topics related to Ten Principles of UN Global Compact. This creates lot of awareness about the pertinent issues through both online and offline engagement with various stakeholders.

3. We have engaged with 150,000+ people through social media and email newsletters to raise awareness about Ten Principles of UN Global Compact amongst various stakeholders. Furthermore, our website has 100,000+ unique visitors during this period.

In the near future, we look forward to engage with more stakeholders, our focus will be to engage with Business Participants and Educational Institutions for research, awareness, sharing of best practices, and commentary on COE activities.
